Arts Project Grants (APG)	March 15th October 1st	\$2,000 min \$7,500 max	All non-profit arts and non-arts organizations, as well as public agencies and subdivisions of government.	Arts Project Grants support arts programming, productions or events open to the general public. The program or event may have multiple components and/or performances.	Organizations and college/university departments may apply for <u>either</u> one Arts Project Grant or one Arts Learning Project grant per deadline. Organizations receiving Basic Support Grant funding may not apply.
Arts Learning Project Grants (ALG)	March 15th October 1st	\$2,000 min \$15,000 max <i>Note restrictions for requests over \$7,500</i>	PreK-12 schools, school districts, educational service units, or non-profit organizations may apply. All projects primarily targeting youth must apply in the ALG or AiS/C grant categories.	Arts Learning Grants support programs with a strong educational emphasis for youth or for adult learners. Projects may take place in preK-12 schools or can be based in community settings.	Requests over \$7,500 must be school-based, with more than one school, or must involve significant outreach in multiple communities. Basic Support Grantees may apply for Arts Learning Project Grants ONLY if they are school-based or are for outreach initiatives in other communities.
Mini Grants (MG)	6-12 week floating	\$2,000 maximum	All nonprofit arts and non-arts organizations, as well as public agencies such as schools and subdivisions of government.	Mini Grants provide funding for arts projects that take place within a defined period of time and are open to the public.	Organizations are allowed to apply twice per fiscal year (July 1 - June 30). Basic Support Grantees should contact NAC staff about restrictions.
Artists in Schools/Communities (AiS/C)	6 week floating if request is less than \$2,500 per artist. --- Mar 15 and Oct. 1 if request is greater than \$2,500 per artist.		All nonprofit arts and non-arts organizations, as well as public agencies such as schools and subdivisions of local and state government.	Artist residencies with at least 20 hours of contact time between artists and participants. Sponsors select artists in a variety of art disciplines from those listed in the NAC's Teaching Artist Roster.	Grant funds support only artist fees and related travel expenses. Artist fees and travel per diem are pre-set; see grant guidelines for details.
Nebraska Touring Program (NTP)	6 week floating	45% of the artist fees, up to \$2,000 per contract	All nonprofit arts and non-arts organizations, as well as public agencies such as schools and subdivisions of government.	Help sponsor organizations fund performances or exhibits selected from the NAC Touring Roster, listed on the NAC website.	Sponsors may not select artists or events based in the sponsor's city or within a thirty mile radius.
School Bus for the Arts Grants (SBA)	4 week floating	\$1,000 max	Nebraska accredited public or private schools, pre-K through grade 12 or nonprofit organizations that serve K-12 students.	School Bus for the Arts Grants provide funds for arts related field trips to professional quality performances and exhibitions.	Grant amounts and the number of applications accepted are dependent on how many students are served.
Arts Accessibility Grants - Event Services	4 week floating	\$250 max per event or \$2500 for a series	All nonprofit arts and non-arts organizations, as well as public agencies such as schools and subdivisions of government.	Help underwrite the costs involved in opening performances to all individuals regardless of accessibility barriers.	Applicants can request a maximum award of \$2,500 per fiscal year.
Arts Accessibility Grants - Improvement Projects	LOIs due at least 12 weeks before project start date	\$5,000 max	Nonprofit arts organization incorporated in Nebraska.	Provide funds to improve access to art organization's existing programs or facility for patrons with disabilities.	Not available to schools, colleges, public agencies, subdivisions of government or religious organizations.
